With so much happening in the field of medicine – new treatments, research and new procedures to name but a few, the future for occupational health is both challenging and exciting. The ALAMA Spring Conference: OH – Watch this Space will tackle head-on the issues that OH physicians are having to face, be they clinical, procedural, legal or professional. The programme provides an excellent opportunity for OH physicians to hear from experts, to discuss and debate realistic scenarios, and to have their own voice heard.

The ALAMA conferences have, over the past years, built a reputation as extremely highly regarded sources of information, learning and CPD, as well as key networking and experience sharing events. In order to ensure you get as much as possible out of attending this conference, it has been designed to include ample opportunity for you to input your own ideas, share your knowledge and ask your questions. This two-way communication is pivotal to the programme and is both encouraged and expected. We are looking for practical and positive outcomes which offer us reasoned and reasonable professional and clinical guidance as we face the future.

Several extended sessions have been included in the programme:

- A **Stress** session which will include a platform for various perspectives and which will then centre on several case studies which illustrate relevant scenarios and act as the basis for discussion and learning;
- The **Can't Work Won't Work** session will again feature case studies with the aim of building a consensus on how to tackle complex issues through audience interaction and electronic voting;
- Barrister Professor Diana Kloss and lawyer Anne Pritam will lead the session on **Legal Issues** which will cover a wide variety of topics and, as always, encourage questions and discussion from the floor.

The Future for Occupational Health will also come under intense scrutiny with a debate on the pros and cons of specialists with approved qualifications providing 'pure' services as opposed to an integrated service using GPs with diplomas and OHAs. Introduced by the current presidents of both the Society and Faculty of Occupational Medicine, this debate will include plenty of time for questions and comments.

Clinical and evidence based presentations also play a pivotal role within the programme as the importance of keeping up to date on clinical issues is regularly identified as a top priority in our conference feedback. Leading experts from across the region will cover six areas of specific medical interest to OH physicians.

LOCATION

With an eye to the future, the conference is being held in one of Leicester's most modern hotels with the conference dinner in the National Space Centre.

The **Leicester Marriott Hotel**, Smith Way, Grove Park, Enderby, Leicester, England LE19 1SW is close to the M1 at Junction 21. The nearest mainline station is Leicester and the nearest airport is Nottingham East Midlands which is 19 miles away. The hotel brings together the best in contemporary facilities with care and attention to detail. The large open Atrium Lounge is an ideal place to meet with colleagues. The conference rooms are well designed with natural daylight. Bedrooms are light, spacious, air-conditioned with contemporary furnishings, high speed internet access, in-room safe and a dedicated workspace. It houses the UK's largest domed planetarium and we will be served dinner surrounded by space suits, rockets, satellites and meteorites.
